



HeartBeat-C Boarding HBC Policies

- Please Read -Initial Each Section

Emergency Medical Care: If, in our judgment, your pet requires immediate medical care, and we are unable to reach you, we will take your pet to a veterinarian or animal hospital.

_____ By initialing here, you agree to be solely responsible for the payment of all medical bills for your pet's and you release **Heart Beat-C HBC Boarding**, its officers, directors, agents, volunteers, and employees of and from any and all responsibility for, or claims, damages, debts, arising out of or related to such medical care, including, but not limited to, transportation to/from the veterinary clinic and choice of veterinarian and animal hospital.

_____ Heartbeat- C Boarding reserves the right to immediately change your do pet's type of boarding/daycare if we believe it is necessary to protect the health and well-being of your pet, other pets, or our staff.

_____ All pets must be healthy, and current on all vaccinations. You will be required to bring a copy of your pets updated vaccination records from your vet before you start daycare or board with us to ensure your pets safety as well as that of our existing Heart Beat-C Boarding dogs.

_____ If your pet is exhibiting any symptoms that may suggest illness such as sneezing, coughing, wheezing, runny eyes or nose, vomiting, lethargy, or diarrhea, please do not bring your dog to daycare or boarding. If your pet comes into heat while boarding, you will be charged an extra \$20 per day. Pets with flea or tick problems will be treated, at the owner's expense (\$8/ day).

_____ I acknowledge and understand that there are certain risks involved in day care and boarding, including but not limited to dog fights, bites to humans or other pets, snake bites and the transmission of disease. Any medical expenses will be owners' responsibility and I release Heart Beat-C Boarding of any and all charges.

_____ No choke chains, corrective collars, harnesses will be used without owners' approval and instruction.

_____ All charges must be paid in full upon pick-up of your pet. Pets left 48 Hours beyond the agreed pick-up date without contact will become property of Heart Beat-C Boarding and will be released to Waggin Tales Animal Shelter in Torrington, WY and may be disposed of at the shelters discretion.

_____ The owners are required to provide enough food for the entire duration of their stay. HBC does this to save animals getting upset stomachs due to food changes. If HBC must supplement food, HBC will charge an additional \$5 per day to cover food cost.

_____ Owners are welcome and encouraged to bring their pet's own bedding or toys if desired, however we cannot guarantee that they will be returned in the same condition. HBC will guarantee that no other animals other than your own will use the toys or bedding you provide for your pets. If your pet destroys HBC equipment you will be subject to additional charges.

_____ Pick-up/ Drop-off times are by appointment only and scheduled per owner. Business office hours: Monday through Friday 10:00am / 3:00pm. HBC will provide a 3 Month Calendar to show Black Out Periods when requested.

_____ We accept cash, or check (please note, there is a \$30 returned check fee). Payment is due upon pickup of your pet. HBC reserves the right, without notice, to adjust its fees for services. Please inquire as to our current fees. By submitting this form,

_____ You indicate your agreement with all the terms listed hereof,

_____ You release, indemnify, and agree to hold Heart Beat-C HBC Boarding harmless from any and all manner of damages, claims, loss, liabilities, costs or expenses, causes of actions or suits, whatsoever in law or equity, (including, without limitation, attorney's fees and related costs) arising out of or related to the services provided by Heart Beat-C Boarding, except which may arise from the sole gross negligence or intentional and willful misconduct of Heart Beat-C Boarding, including, without limitation, (i) any inaccuracy in any statement made by yourself or information provided by you to Heart Beat-C Boarding, (ii) your dog, including but not limited to destruction of property, dog bites, injury, and transmission of disease, and (iii) any action by yourself which is in breach of the terms and conditions of this agreement.

_____ This agreement covers the current relationship between Heart Beat- Boarding HBC and yourself. Each time you bring your pet to Heart Beat-C Boarding, you affirm the terms of this Agreement, and the truthfulness and accuracy of all statements you make in this Agreement.
